ADDITIONAL TERMS AND CONDITIONS

- Sponsor Benefits: Sponsor shall be entitled to all benefits and rights in accordance with the selected package and options aforementioned. Promotional benefits will not be activated until payment and logo are received by ASID MOW-KS.
- 2. Sponsor Obligations:
 - a. Full sponsorship level shall be payable in full with the execution of this Agreement. The sponsorship fee includes all benefits set forth herein.
 - b. Sponsor shall provide high resolution company logo and hyperlink (if required) to be used on ASID MOW-KS website and other promotional materials. Sponsor understands and agrees that failure to provide such copies in a timely manner may result in exclusion from ASID MOW-KS promotional materials, which shall not be considered a breach by ASID MOW-KS of this Agreement.
 - Sponsor acknowledges, covenants and agrees that the recognition and sponsorship
 activities as described herein do not constitute an endorsement or recommendation by ASID
 MOW-KS of any product, service, or other activity of Sponsor.
- 3. License, Intellectual Property: Each Party shall have the limited, non-exclusive, revocable, royalty-free right to use one another's name, logo, and trademarks in advertising and other materials to carry out their respective obligations under this Agreement. Notwithstanding the above, ASID MOW-KS shall have the right to review and approve or reject any use of its trademark, name, or any of its intellectual property. Neither Party shall use one another's name, logo, or trademarks in a harmful, false, misleading, or disparaging manner.
 - a. Sponsor represents and warrants that any advertisement, logo, design or other content it supplies to ASID MOW-KS pursuant to this agreement will not defame, libel or slander any third party; that it will not invade the privacy, right of publicity or other personal rights of any third party; and that it will not infringe on or otherwise violate the copyright, trademark, trade secret, patent or other intellectual property rights of any third party.
- 4. Limitation of Liability: ASID MOW-KS makes no warranties, either express or implied, regarding the appearance of Sponsor's content, including but not limited to the warranty of merchantability or fitness for a particular purpose. Sponsor agrees that ASID MOW-KS will in no event be liable for any punitive, consequential or third party damages, including but not limited to lost profits, even if Sponsor has advised ASID MOW-KS of the possibility of such loss. In no event shall ASID MOW-KS's liability to Sponsor exceed the fees Sponsor has paid to ASID MOW-KS in the previous six months. Further, for purposes of this Agreement the term "ASID MOW-KS Chapter Person" shall mean any present or former ASID MOW-KS officer, director, member or employee. As a material inducement on the part of ASID MOW-KS to enter into this Agreement, Sponsor agrees that: (a) To the extent that the proceeds, if any, from any insurance policy maintained by ASID MOW-KS are insufficient to satisfy any judgment obtained against ASID MOW-KS or any ASID MOW-KS Chapter Person, only the assets of ASID MOW-KS, not the individual assets of any ASID MOW-KS Chapter Person, may be used to satisfy any such judgment requiring the payments of monies; (b) To the fullest extent permitted by law, and except for ASID MOW-KS's obligation, if any, under this Agreement to pay Sponsor certain fees, the maximum collective liability of ASID MOW-KS to Sponsor or to anyone claiming through or under Sponsor for any injury, loss or damage shall not exceed the greater of (i) the available proceeds of any insurance policy maintained by us or (ii) the sponsorship fees paid by

- Sponsor for the preceding six months; (c) ASID MOW-KS shall not be held responsible for (i) the negligence or willful misconduct of third parties; (ii) the negligence or willful misconduct of Sponsor or (iii) the non-performance of third parties.
- 5. Indemnification: Sponsor agrees to defend, indemnify and hold harmless ASID MOW-KS, its parents and affiliates together with their respective employees, agents, directors, officers and members, from and against all liabilities, injuries, claims, damages and expenses, including but not limited to reasonable attorney's fees and costs, arising out of Sponsor's advertisement or other content provided to ASID MOW-KS for use on the website or in the ASID MOW-KS newsletter, Sponsor's breach or alleged breach of this Agreement, or Sponsor's breach or alleged breach of the copyright, trademark, proprietary or other rights of any third party. Sponsor's liability shall be limited only in the case that such liabilities, injuries, claims, damages and expenses result from the willful misconduct or gross negligence of ASID MOW-KS.
- 6. Relationship of the Parties; No Assignment: This Agreement does not constitute a partnership or joint venture or principal-agent relationship between us. This Agreement may not be modified or assigned by either party without the written consent of the other party. Parties further understand and agree that only the Missouri West-Kansas Chapter of ASID, not the American Society of Interior Designers, Inc. is a party to this Agreement. Under no circumstance shall the American Society of Interior Designers, Inc. be subject to any dispute or claim arising out of this Agreement.
- 7. Termination: ASID MOW-KS may cancel this Agreement immediately at any time upon written or electronic notice to Sponsor. The failure of Sponsor to perform any service under this Agreement or a failure to perform any provision under this Agreement will be considered a Breach of Agreement and ASID MOW-KS shall be able to terminate this Agreement and seek any damages. Sponsor understands that all payments to ASID MOW-KS are final and nonrefundable.
- 8. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Missouri. Any claim arising out of this Agreement shall be brought to a court of competent jurisdiction in the State of Missouri.
- 9. Compliance with Laws: Parties represent and warrant that as of the Effective Date of this Agreement Parties are in compliance with all applicable federal, state, and local laws, regulations, and ordinances necessary to carry out their obligations under this Agreement. Parties shall be individually responsible for maintaining compliance with such laws and regulations.
- 10. Entire Agreement: This Agreement is complete and represents the entire agreement between the parties. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. If any provisions of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid or enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited
- 11. Changes to these Terms and Conditions. ASID MOW-KS may amend these Terms and Conditions at its sole discretion with notice to Sponsor. Platinum and Gold levels have open scheduling opportunities upon availability and or Feb.15th of the contracted year. After Feb. 15th Sponsorship opportunities are open to all Sponsorship levels upon availability.
- 12. Force Majeure. Neither party shall be liable or responsible to the other party, or be deemed to have breached these Terms and Condition, for any failure or delay in fulfilling or performing any of these Terms and Conditions, when and to the extent such failure or delay is caused by or results from acts beyond the impacted party's ("Impacted Party") control, including, without limitation, the following force majeure events ("Force Majeure Events"): (a) acts of God; (b) flood, fire, earthquake, or explosion; (c) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot or other civil unrest; (d) government order, law, or actions; (e) embargoes or blockades in effect on or after the date of this Agreement; and (f) national or regional emergency; and (g) other similar events beyond the control of the Impacted Party.
